VOTER REGISTRATION**

The Montgomery County Election Commission is open for voter registration for the State Primary and County General Election to be held on Thursday, August 2, 2012 in Montgomery County, Tennessee.

All persons who have moved their residence are required to change their registration records with this office or they will be purged/removed from the records.

If you attempted to register to vote at the Department of Safety, Department of Human Services, another state agency, or if you registered by mail but you have not received a voter registration card, you should contact the office immediately at 931-648-5707.

The **LAST DAY** before this election to register to vote is July 3, 2012.

**EARLY VOTING** by personal appearance (no reason required) at the Election Commission Office will be July 13-28, 2012.

**INACCESSIBLE POLLING PLACE** – TCA 2-3-109 provides that if a polling place is inaccessible to any elderly voter or voter with a disability, those persons have the right to vote early or at the Election Commission Office on Election Day. To vote at the Election Commission Office on Election Day, such voters must give written notice to: The Election Commission, 350 Pageant Lane, Suite 404, Clarksville, TN 37040, of their intention to do so no later than July 23, 2012.

**NEW STATE LAW** – Federal or state government issued photo ID is now required to vote, unless an exception applies. College student IDs will not be accepted. To learn more about the new law and its exceptions, go to [www.mcgtn.org/election](http://www.mcgtn.org/election)
