**Qualifying Deadline: February 15, 2018  
at 12:00 NOON**

This deadline applies to all candidates, including independent candidates.

**Withdrawal Deadline: February 22, 2018  
at 12:00 NOON**

A candidate's request to withdraw must be filed with the county election office in writing.

**Voter Registration Deadline: April 2, 2018.**

By mail applications must also be postmarked by April 2, 2018. Any Montgomery County resident needing to register to vote, change their name or change their address may do so online at govotetn.com. By mail voter registration applications are also available at all local USPS locations and the Public Library. To register or update a registration in person, visit the Montgomery County Election Office.
